Recall Description

General Motors has decided that certain 2021 – 2024 model year Chevrolet Silverado, Tahoe, Suburban, and GMC Sierra, Yukon/Yukon XL, and Cadillac Escalade/ Escalade ESV, vehicles may not conform to section 19 (a) of Canada Motor Vehicle Safety Standard (CMVSS) No. 108, "Lighting Systems and Reflective Devices". The standard requires lower-beam headlamps to automatically activate in less than two seconds when the ambient light outside the vehicle is less than 1,000 lux in certain conditions. In these vehicles, automatic headlamp activation may be delayed for a short period of time in certain conditions. During that time, the vehicle could be less visible, increasing the risk of a crash.

Remedy

General Motors will update the software in the vehicles' Body Control Module (BCM) to correct the condition. Owners who have accepted applicable terms and conditions will have the opportunity to accept these software changes using wireless over-the-air (OTA) technology without having to bring their vehicle to a dealership. Alternatively, owners may schedule to have the updates performed at a GM dealer.
